QUALIFIED DOMESTIC RELATIONS ORDER
Plan Participant Not in Pension Pay Status

It is the intent of the Court that the provisions of this domestic relations order ("Order") operate as a selective assignment of the Participant's interest in the Pension Fund set forth below to the Alternate Payee under both state and federal laws, for all purposes and constitute a Qualified Domestic Relations Order ("QDRO") in compliance with Section 414(d) of the Internal Revenue Code of 1986, as amended ("Code") and Section 401(a)(3) of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").
